## Frequently Asked Questions for International Shipment Promotion (1<sup>st</sup> Jun 2021– 31<sup>st</sup> July 2021)

**Q1:** How long is the promotional period?

**A1:** *The promotional discount applies to shipments (both document and parcel) picked up or lodged in between 1<sup>st</sup> Jun 2021 until 31<sup>st</sup> July 2021.*

**Q2:** How do I know whether I am eligible for this promotion?

**A2:** *As long as your shipment weight is above 2kg, you will be eligible for this promotion.  
e.g.: shipment weight is 2.01kg.*

**Q3:** How do you calculate the promotional rate, after applying the discount?

**A3:** *Assuming that the discount rate for Country A is 10% and the base shipping rate is RM35.00 with a temporary additional international surcharge of RM5.00 (if applicable), the discounted shipping rate will be:*

**A5:** *This temporary surcharge was imposed on selected countries since April 2020, following the Covid-19 pandemic which had adversely affected the global air freight industry.
